TERMS AND CONDITIONS

- 1. IDENTIFICATION:** A valid state-issued driver's license or government-issued photo ID is REQUIRED at pickup. No equipment will be released without proper identification. A copy of your ID will be retained on file.
- 2. RENTAL PERIOD:** Standard rental period is 24 hours from pickup. Late returns will be charged an additional full day's rental fee for each day or partial day.
- 3. CONDITION:** Renter acknowledges receiving equipment in good, clean, working condition and agrees to return it in the same condition. Damage, loss, or excessive wear will be charged at replacement cost.
- 4. SUPERVISION:** Adult supervision is REQUIRED at all times during use. Renter assumes full responsibility for safe operation and supervision of all rented items.
- 5. ASSUMPTION OF RISK:** Renter acknowledges that use of carnival games and party equipment involves inherent risks and voluntarily assumes all risks associated with use.
- 6. INDEMNIFICATION:** Renter agrees to indemnify, defend, and hold harmless Pensacola History and Haunting Tours and Events, its owners, employees, and agents from any claims, damages, losses, costs, and expenses arising from use of rented equipment.
- 7. LIABILITY WAIVER:** Renter releases and waives any claims against Pensacola History and Haunting Tours and Events for any injury, damage, or loss during the rental period.
- 8. PAYMENT:** Full payment is due at pickup. Accepted forms: cash, credit card, or other approved methods.
- 9. CANCELLATION:** Cancellations less than 48 hours before pickup may be subject to a cancellation fee.
- 10. GOVERNING LAW:** This Agreement shall be governed by Florida law. Disputes shall be resolved in Escambia County, Florida.
